rothers, as we prepared for our issues forum at the Congressional Black Caucus Annual Legislative Conference, September 20-24, 2017, I reflected on the many areas that Omega men have touched working on fatherhood and mentoring.

Much of what we face is a result of the issues that impact our lives as Black men. As members of Omega Psi Phi Fraternity, Inc., we played an important part in the historic Presidency of former President Barack Obama through our partnership with the White House.

When President Obama was in office, among his important platforms were his **Fatherhood Mentoring Initiative**, which uplifted the critical role fathers and men play in the lives of their children, families and community, and the **My Brother's Keeper** initiative, a program that addressed the challenges facing young Black men and boys.

He took an aggressive leadership role in working on Criminal Justice Reform, issues such as Mass Incarceration, Employment, Education, Affordable Healthcare, Mental Health, and Racial Justice. These areas have implications for fathers and men.

CBCF Presents President Obama's Legacy on Fatherhood, Black Men and Boys Congressman Speaks on Persistence and Perseverance at CBCF/Omega Psi Phi Fraternity **Fatherhood and Mentoring Forum** By George D. Taylor

Washington, DC, September 21, 2017 – A CBCF (Congressional Black Caucus Foundation) issues forum hosted by CBC Member, the Honorable Congressman James E. Clyburn, Democrat, South Carolina's 6th District and the Omega Psi Phi Fraternity, Inc., International Committee on Fatherhood and Mentoring was held Thursday, September 21, 2017 at the Washington, DC Convention Center.

Brother Thabiti Boone, Fatherhood Representative and Liaison to Former President Barack Obama's White House and Robert W. Fairchild, Chairman of the committee convened a distinguished panel of subject matter experts to discuss several hot button issues facing the African American community.

Brother Boone Opened the session by introducing Congressman Clyburn, a member of the Omega Psi Phi Fraternity, Inc., who spoke of being awaken one morning with news about University of South Carolina football player, Tyshun "Deebo" Samuels, a junior and wide-receiver on the football team, who scored on the first play from scrummage but will

miss most of the season after suffering a fractured left fibula during the third quarter of the loss to Kentucky. Congressman Clyburn then told of Bo Jackson, former NFL player who fractured his hip and which ended his football career. Clyburn said, our charge as Omega men and Black men generally, is to prepare these young men to deal with life's realities for the rest of their lives. "It is our job in these fraternities to prepare these young men for life," he said.

Brother Clyburn ended his remarks telling of his first three political failures. He appealed to the audience to "Never Give Up." Had he given up and quit the game, he said he would not have been where he is today – the third most powerful Democrat in the House of Representatives of the United States of America. Quoting the age-old adage, he said, "If at once you don't succeed, try, try again." He said to the audience excitedly, "Stay in the game. Our society does not move in a linear plane. It moves back and forth – left to right – and right to left - politically and socially." He asserted that we can make a difference when we work together and get involved in the process. "The pendulum," he said, "spends twice as much time in the center than on either side. So, stay in the game but always be prepared."



bout Child Support: Brothers, there is not a more disconcerting and consternation creating issue involved with parents who are estranged from their children than the issue of **Child Support** (CS).

Child Support is the short hand term for the statutory (in the overwhelming majority of states)

requirement that the material needs of children of estranged families must be provided for. State legislatures have made it the law that when parents' divorce or when children are born outside of wedlock, those children must be provided for by the mother and father who have decided to go their separate ways.

There are some basic, general concepts that should be acknowledged at the start of our discussion:

- Every child has the right and the need to be provided for materially until they are considered to be recognized as an adult. In virtually every state that age of adulthood is considered 18 years of age.
- It is the responsibility of the two legal parents to ensure that those material needs are sufficiently met.
- When legal parents are divorced or have never married, the non-custodial parent (NCP) is usually looked to be required to contribute money, insurance coverage to the household where the child(ren) reside.
- As I have continually emphasized, parents have the right, generally, to agree to establish their own terms/agreements between themselves. Child support is certainly no different. The more parents can agree to between themselves, the less the court system is required to intervene and call the shots about what happens!!
- Neither parent has the authority to negotiate away a child's right to receive financial support from the NCP.
- Failure to provide sufficient child support, whether established by court mandated order or by stipulated agreement of the parents, is actionable in court. It is considered contempt of court to fail to pay court ordered child support. A finding of contempt can result in loss of state issued licenses and could result in being incarcerated.
- In the State of Michigan, and I would imagine most other states, CS follows the child. That means that procedurally, support payments are paid by the NCP to the caretaker of the minor child, for the benefit of the

child. Normally that means that the Custodial parent receives the payment. As an example, in situations such as a child being placed in a legal guardianship with a third person (i.e. neither parent has the legal or physical custody of the child), the support must be paid to the legal guardian. It is also appropriate in that type of situation that both parents must contribute to the support paid to the third party caretaker.

Over the next few columns, we will delve deeper into the issues raised by Child Support, as well as other perspectives on this incredibly hot-button issue. As we move forward, there is no better antidote to the difficulties that plague our families and communities in this realm, than clear, accurate information.

re women the only victims of domestic violence? No, men are also victims of domestic violence.

In my practice, I serve male and female offenders. Victims of domestic violence have unique needs, especially men. My intent will never imply nor minimize the hardship of any victim. My view is informed by my years of intervention and advocacy. According to a report issued by the Centers for Disease Control and Prevention (CDC), one in four adult men in the U.S. will become a victim of domestic violence during his lifetime.¹

This article will speak to three tactics experienced by men I serve. Those are: isolation, the children or emotional attacks piled upon them.

Isolation is one of the most common forms of abuse. It is very subtle. It has an appearance of protection. However, the intent is to control. Several of the men we work with experience abuse. Then, in defense of themselves they say, "I'm just keeping peace at home." Men have friends,

family, and associates prior to entering into an intimate relationship. In some cases, their work community has value. Some that I counsel mourn the loss of those relationships. Too often, isolation causes relationships to suffer.

Another form of abuse reported by those I work with is using children. I had a case once; the guy was at his ex's house to pick up the kids. He was met at the door by his ex and her family. She tells him, "You can't get your kids if they will be around that b!&?@(." In tears, he asked me, "What can I do? I'm trying to move on with my life. We haven't been together for 2 years. I don't know what to do. This \$#!) ain't right!" I referred him to an attorney to handle the legalities of visitation. Then suggested the use of a safety plan to interact with his ex. A safety plan is a method used by victims of intimate partner abuse to create the safest interaction when there is potential contact with someone who may cause harm. In his case, he needed to implement a better drop off and pick up plan for the children.

The most volatile form of abuse is using emotional abuse. Men I support claim they are often embarrassed in front of their friends and family by comments or gestures made by their mate. Further, they suggest frequent verbal jabs with ranges from employment or income to educational status or life achievement. Sex or the lack thereof fits into this category as well. Many frustrated clients speak about this at length during visits. Emotional abuse, in my opinion, is a silent killer. It corrodes the psyche until rage or some unhealthy form of behavior becomes common place.

Today men suffer in silence. They fail to reach out due to self-pride, too much manhood, or shame. I hope this article creates an opportunity for many to reach out for help before it's too late. Male victims of intimate partner violence exist in our society, unfortunately. As men, we must put away the vice(s) keeping us from living a healthy lifestyle. The decision is difficult but necessary. Find a way. Your next step can be your best step.

The annual mission for the 500 Miles of Freedom College and Civil Rights Tour is to highlight the sacrifices that were made in order for us to as a nation to have the freedoms of today. For some this is a once in a life time opportunity that ensures national exposure outside of the Tallahassee community.

During a time where every community could use more positive platforms for their youth, parents of the Lamplighters are overjoyed knowing that their children have genuine role models and security without them being present.

Vardyce Gaines is the Father of a Lamplighter and has always expressed the importance of giving back to his son. "This program has made him stand out as a leader and

has also helped build confidence in himself." Gaines said. "It's also important that he is learning responsibly and comradery at such an early age.
