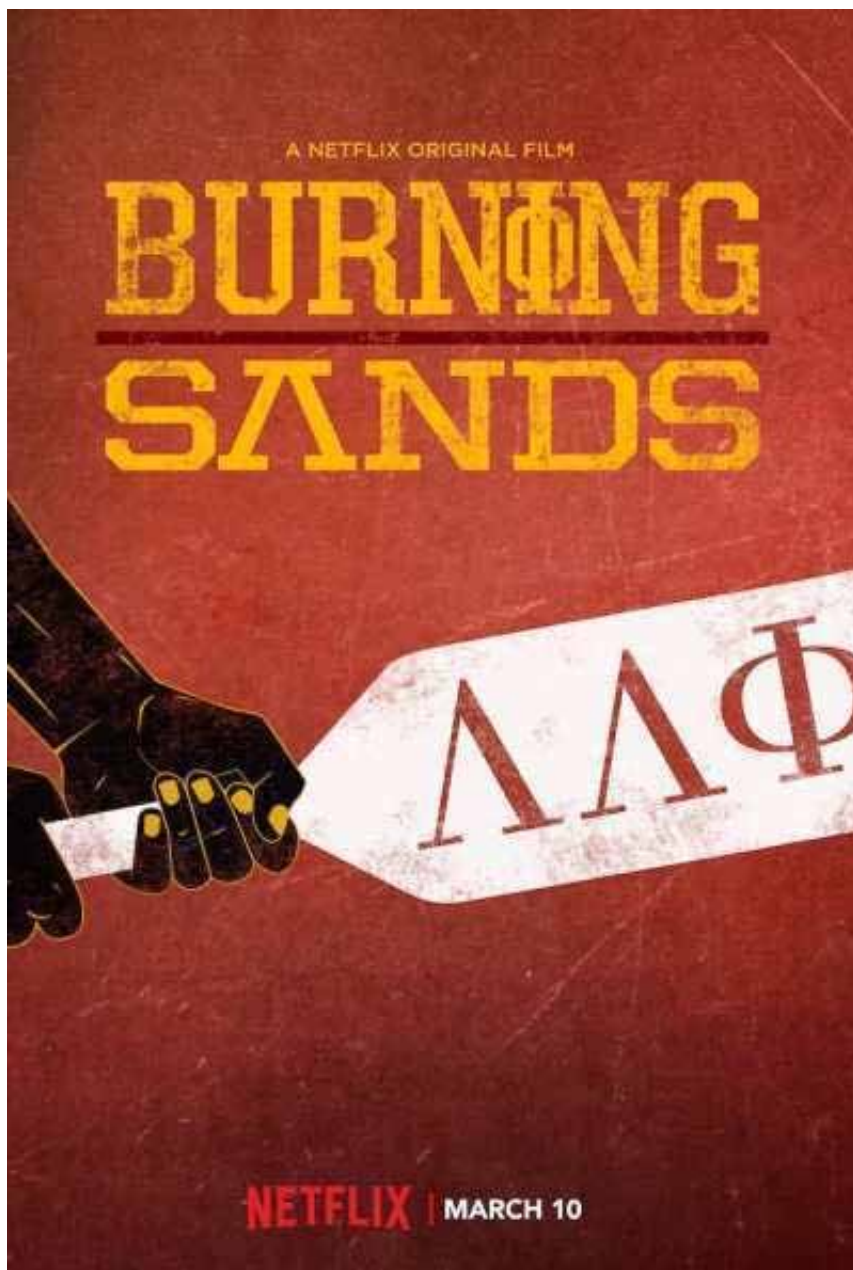

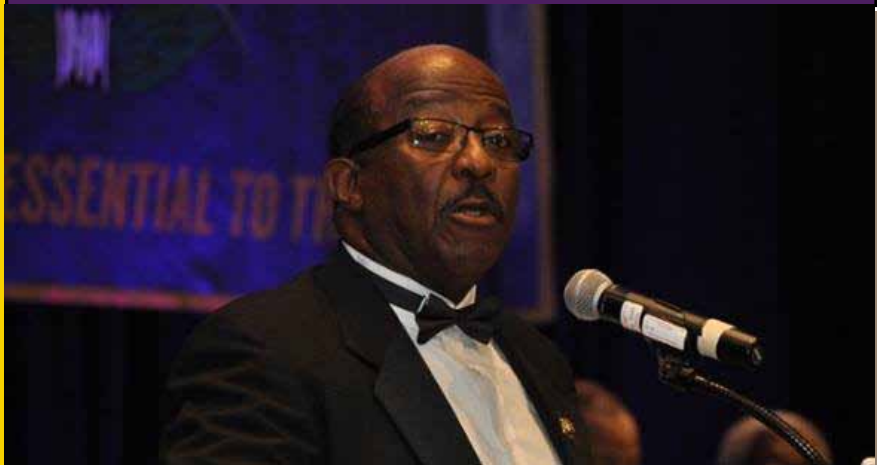

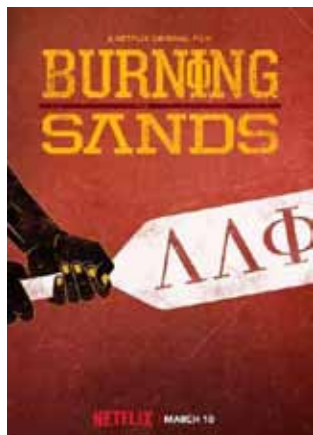

## Omega Men on the Move

### Brother Ricky D. Smith, Sr. Executive Director and CEO of the Maryland Aviation Administration



Maryland Governor Larry Hogan appointed Brother Ricky Dorell Smith as Executive Director/CEO of the Maryland Aviation Administration (MAA) on July 10, 2015. Mr. Smith is responsible for the planning, operation, and management of Baltimore/Washington International Thurgood Marshall Airport (BWI Marshall), Martin State Airport, and regional aviation activities for the State of Maryland.

Brother Smith, a 27-year transportation official, returned to Maryland after serving as the Director of the Department of Port Control for the City of Cleveland since June 2006. In that capacity, he served as the Chief Executive Officer of the Cleveland Airport System, which includes Cleveland Hopkins International Airport and Burke Lakefront Airport. In addition, he was responsible for overseeing the development and management of the City's lakefront properties.

Brother Smith worked to establish and execute a strategic direction for

Cleveland Hopkins International Airport that included expanding airport revenue sources, strengthening the airport's brand recognition, improving airfield safety, and enhancing the passenger experience. During Mr. Smith's leadership in Ohio, Cleveland Hopkins was recognized as the most-improved airport in North America by the international aviation industry organization, Airports Council International-North America. He led the development of a new \$2 billion master plan for the Cleveland Airport System that is developing new cargo facilities and expanded corporate hangars, improved parking facilities, a new on-airport hotel, an improved passenger terminal building, a new on-airport service station/fast food plaza, and a new state-of-the-art FAA Air Traffic Control Tower. Prior to his service in Cleveland, Brother Smith served as the Chief Operating Officer for the MAA. Brother Smith helped lead BWI Marshall Airport through a \$2 billion expansion program, increased air service throughout the world, and the creation of a new food and retail program. Prior to returning to the MAA after a two-year departure, Ricky served as the Deputy Administrator for the Maryland State Highway Administration. There, he oversaw an approximate \$1 billion annual budget and co-developed the financing strategy for the largest capital project in Maryland history – the Inter-County Connector. In addition, he served in the private sector for several years with International Business Machines, H&R Block Business Services, The May Company, and others.

Ricky holds a degree in Business Administration and Accounting from Howard University and an Executive MBA from Loyola University in Maryland. He is a graduate of a number of leadership programs, including Leadership Cleveland, the Greater Baltimore Committee, Leadership Anne Arundel, and the University of Maryland Government Executive Institute. He is active on several national and local boards and industry associations including the American Association of Airport Executives, the Airport Minority Advisory Council, the BWI Business Partnership, and the U.S. Department of Transportation National Freight Advisory Council.

Brother Ricky Smith was initiated into Omega Psi Phi Fraternity through Zeta Chapter in 1981 and resides in Howard County Maryland.

### Brother Osborne Robinson, III Promoted Chief of Patrol Baltimore City Police Department



On July 13, 2016 Baltimore City Police Department announced the reorganization of command staff and Brother Lt. Col. Osborne Robinson III was promoted to Chief of Patrol. A United States Army Veteran with service in Bosnia and Herzegovina, Brother Robinson is a highly experienced Law Enforcement Professional who has demonstrated the ability to lead diverse law and order teams to the successful completion of a variety of missions in administrative and operational capacities. Exposure to assignments within the Continental United States, as well as abroad he possesses strong technical and tactical qualifications with an impressive track record of more than 20 years of hands-on service in the field of criminal justice.

Brother Robinson is a 1992 graduate of Salisbury University in Maryland, Military Police School and possesses certificates in Organizational Leadership and Polygraph from the University of Maryland and Northeast Counterdrug Training Center, respectively. Brother Osborne Robinson III has served on the Baltimore City Police Department since 1993 and was initiated into Omega Psi Phi Fraternity through Pi Omega Chapter in 1999.

### Brother Mohan Suntha, MD. President and CEO of the University of Maryland Medical Center



In May 2016, after a nationwide search, Brother Dr. Mohan Suntha was appointed President and CEO of the University of Maryland Medical Center which includes the Shock Trauma Center, Children's Hospital and the Greenebaum Comprehensive Cancer Center as well as the Midtown Campus. Prior to his appointment as President and CEO of the University of Maryland's St. Joseph Medical Center In December, 2012, Brother Dr. Suntha held numerous administrative roles within the Medical System and School of Medicine. He served as vice chairman of the Department of Radiation Oncology, University of Maryland School of Medicine and the associate director of clinical affairs at the University of Maryland Greenebaum Comprehensive Cancer Center where he is the Marlene and Stewart Greenebaum Professor of Radiation Oncology. In 2009 he was appointed as the vice president for system program development for the University of Maryland Medical System.

Brother Dr. Suntha joined the Department of Radiation Oncology at the University of Maryland School Of Medicine as an assistant professor in 1995, after completing residency training in Radiation Oncology at the University of Maryland School of Medicine. Brother Dr. Suntha received his BA from Brown University in 1986, where he was initiated into the Omega Psi Phi Fraternity, Inc. through Theta Epsilon Chapter. He earned his medical degree from Jefferson Medical College in 1990 and completed an internship in Internal Medicine at Bryn Mawr Hospital in Pennsylvania. In May, 2009, he earned an MBA from The Wharton School of Business at the University of Pennsylvania.

Brother Mohan Suntha was initiated into Omega Psi phi Fraternity in 1986 through Gamma Chapter in Boston, MA.

### Brother Ivan J. Bates, Esq. Premire Defense Attorney



Brother Ivan Bates, ESQ. has handled a number of high-profile cases as a criminal defense attorney. Bates currently represents Baltimore police Sgt. Alicia White, one of the highest ranking officers charged in connection with the death of Freddie Gray. He previously defended a Drug Enforcement Agency agent in the Silk Road case that ultimately led a federal judge to sentence the founder of the illegal online marketplace to life in jail.

Bates has also been on the other side of the courtroom as an assistant state's attorney with the Baltimore City State's Attorney's Office. But one

of the most rewarding aspects of his career involves providing legal services to "others who didn't really think they could have had a good lawyer," Bates said. In some cases this has involved pro bono work, but it's also meant providing counsel at a discounted rate to a mother working an extra shift to pay for a lawyer to represent her son, he said. "It's the cases that no one has really heard about, the kids that I'm able to give a second chance, those are the cases I'm most proud of," Bates said. Another career highlight has been starting his own firm, Baltimore-based Bates & Garcia PC, in 2006. "I like having my own business," he said. "It lets you put your career in the direction you want it to go. It's very rewarding." He also gives back to his community and those he cares about: He created a nonprofit, the Baltimore United Foundation, to provide small donations mostly to local sports teams for new uniforms or a trip to a tournament, he said. He also makes it a point to speak and mentor to youth in the community, as he was mentored by two loving parents and a broader community that supported him. "I think being an African American, seeing how these younger kids look up to me, I'm able to sit down with them and help them understand some of the pitfalls and obstacles that are there," he said.

Following his tour of duty, in the United States Army, 32nd Air Defense Artillery, he became an honor graduate of Howard University, School of Communications, Ivan received many prestigious awards and honors including the Lyndon Baines Johnson Internship and the General Motors Volunteer Award. He continued his education earning his Juris Doctorate at College of William and Mary, School of Law. There he was a recipient of the Public Service Fellowship, a member of the Black Law Student Association. A life member of Omega Psi Phi Fraternity, Inc., initiated through Alpha Alpha Chapter in 1994, he is currently a member of Pi Omega Chapter in Baltimore, MD.

### Brother Nick J. Mosby Selected as Member of Maryland State House of Delegates



In February 2017, Brother Nick J. Mosby started his new job as a member of the Maryland House of Delegates after he was chosen by the State Central Committee to fill a vacancy triggered by former Maryland State Legislator Catherine Pugh's election as Mayor of the City of Baltimore. Brother Mosby gave up his seat on the Baltimore City Council to

run for Mayor against Senator Pugh last year. As new representative of the Maryland State's 40th Legislative District said he wants to go after manufacturers of toxic lead paint, boost property values and school performance in West Baltimore and make all city streets safer.

During the 2015 Baltimore protests over the Freddie Gray death, Brother Mosby represented Baltimore City District 7, where the worst of the rioting happened. He was at the forefront of the activity and was seen with reporters on all national broadcasts covering the Baltimore unrest. He served his community with distinction and honor during these turbulent times. His wife, the Honorable Marilyn Mosby, Baltimore City States' Attorney, prosecuted six Baltimore City Police Officers in the Freddie Gray death.

Brother Nick J. Mosby is a proactive leader with innovative problem solving abilities with a record of achievement as a strategic partner in accomplishing objectives for corporations and communities. An inter-governmental affairs organizer experienced in developing and executing strategic plans by successfully engaging grassroots and grassroots organizations and constituencies, he has a strong background in technical engineering, sound budget and project management skills, and labor policy. Brother Mosby has a Bachelor of Science in Electrical Engineering from Tuskegee University and Masters of Science in Telecommunications Management from Stevens Institute of Technology. Brother Carlton Saunders is one of the recipients of the BEYA (Black Engineer of the Year Award) Modern Day Technology Leader. According to Career Communications Group, the originator and force behind BEYA, the award recognizes "the leaders in corporate America who are doing the things that keep our country going, shaping the future of engineering, science and technology".

Brother Carlton Saunders, one of the Booz Allen Hamilton's Army Systems Delivery Group's team members, has been nationally recognized this year for his contributions in the field of Information Technology. The fast-rising Booz Allen Hamilton Lead Engineer was one of ten company employees named a Modern Technology Leader at the Black Engineer of the Year (BEYA) Conference awards ceremony. To be considered for the MDTL award, a nominee must: Have 5+ years expertise and/or academic qualification in STEM, Participate in community outreach activities, es-

pecially ones that demonstrate leadership in the STEM community or as a role model for youth, Demonstrate achievements that qualify as "pioneering" efforts as an architect of change in STEM and Have an impact on their business unit or client. The award is given out at the 31st Annual BEYA STEM Global Competitiveness conference in Washington DC. Conference was Feb 8-10 at the Washington Marriott Wardman Park Hotel.

Brother Saunders graduated with an Economics degree from University of Maryland, and a Master's in Telecommunications Engineering from the Stevens Institute of Technology. He entered the IT field fourteen years ago with Verizon and has been with Booz Allen Hamilton for the past three years.

Saunders said that Booz Allen Hamilton's approach to its employees is different from companies he was worked for in the past. "Booz Allen is so different in that it offers so many different ways to help you get oriented into the company and focused to help your customers.

"My first job was as a network engineer with Verizon, and I progressed from that into Engineering Management," he explained. After that I moved into US Army support, contracting as an Operations and Sustainment Deputy Program Manager. From that I come here to support the Software Engineering Center of the Army.

"I get a lot of satisfaction helping the Software Engineering Center fulfill its mission as the integrator and sustainer of the Army's most complex systems," Saunders added. "But there is also the people aspect, and that is the part you really get to look forward to—to positively impact the group of folks on your team. The work will always get done, but it's time that we spend working together as a team to get the work done with people that I can learn from—that is the important part."

### Brother R. Scott Dingle Brigadier General



Brigadier General R. Scott Dingle is a Distinguished Military Graduate of Morgan State University. He commissioned as a Medical Service Corps Officer through the ROTC Program. Initiated into Omega Psi Phi Fraternity in 1984 through Pi Chapter at Morgan State University, his degrees include Master of Science in Administration Degree from Central Michigan University, Master of Military Arts and Science Degree from School of Advanced Military Studies and a Master of Science Degree in National Security Strategy from the National War College.

Brigadier General Dingle's service began as an Ambulance Platoon leader and Motor Officer, 75th Forward Support Battalion, 194th Separate Armored Brigade. His next assignment was to McDonald Army Community Hospital, Fort Eustis, Virginia where he served as an Adjutant; Chief, Plans, Operations, Training, and Security. He assumed Command of the Medical Company and Medical Hold Detachment in 1991. From 1992 to 1995 he served in Germany as the Commander of Charlie Company, 3d Forward Support Battalion. After command he served as the 3rd Infantry Division Plans Officer

for the Division Medical Operations Center. In July 1995, he became an Instructor with the Army Medical Department Center and School Officer Basic and Advanced Courses. In January 1999, he returned to Germany as the 1st Armored Division's Chief, Division Medical Operations Center. He next attended Command and General Staff College and the School of Advanced Military Studies at Fort Leavenworth, KS (2001-2002).

His follow on utilization assignment was to Fort Bragg as the Assistant Chief of Staff, Plans and Exercises, 44th Medical Command and 18th Abn Corps Plans officer. In December 2002, Brigadier General Dingle deployed to OPERATION ENDURING FREEDOM as the Ground Combat Planner for Combined Joint Task Force -180. He next served as the Executive Officer, 261st Area Support Medical Battalion (44th MEDCOM) and later as Chief, Medical Plans and Operations, 18th Airborne Corps Surgeon's Office. In December 2004, he deployed in support of OPERATION IRAQI FREEDOM, as Chief Medical Plans and Operations Multinational Corps-Iraq Surgeon's office. In June 2006, he returned to the states and was assigned to the Office of the Surgeon General as Chief, Current Operations, Special Plans Officer, and later as Healthcare Operations Executive Officer. From 2009-2010, he commanded the 261st Multifunctional Medical Battalion, Fort Bragg, North Carolina.

Brigadier General Dingle next assumed command of the U.S. Army Medical Recruiting Brigade, Fort Knox, Kentucky from July 2010 to July 2012. He relinquished command in July 2012, to attend the National War College. Upon completion of the National War College, he returned to the Office of the Surgeon General as the Director, Health Care Operations/G-3. He was selected for command and assumed command of the 30th Medical Brigade, Germany in May 2014. On 22 June 2015, he became the MEDCOM G-3/5/7.

Brigadier General Dingle is a graduate of the Army Medical Department (AMEDD) Officer Basic Course, The Combined Logistics Officer Advanced Course, The U.S. Army Command and General Staff College, The School of Advanced Military Studies and the National War College.

His awards and decorations include the Legion of Merit (two Oak Leaf Clusters), Bronze Star Medal, Meritorious Service Medal (seven Oak Leaf Clusters), Joint Service Commendation Medal, Joint Meritorious Unit Award, Humanitarian Service Medal, the Order of Military Medical Merit, Recruiters Medallion, the Order of Kentucky Colonels and the Army Surgeon Generals prestigious 9A Proficiency Designator.

### Brother Vaughn M. Bond, Jr. promoted 1st African American Chief of Police in New Castle County, Delaware



**Wilmington, DE. March 21, 2017.** Bro. Vaughn M. Bond, Jr., was promoted to the rank of Colonel and was named the first African American to become the Chief of the New Castle County (DE) Division of Police. Bro. Colonel Bond has 25 years of progressive law enforcement experience, including more than 13 years of police supervisory and management roles within the Division of Police.

On December 9, 1991, Colonel Bond began his law enforcement career as a police officer with the New Castle County Division of Police. During

the next 25 years, he rose through the ranks and managed the Uniform Patrol Section, the Criminal Investigative Unit and recently served as the Police Major, the Commander of the Division's Operations Branch.

He is a highly-decorated officer, receiving a Distinguished Unit Citation, several letters of commendation, 1997 Crime Stoppers Detective of the Year, 1999 runner up for the Crime Stoppers Detective of the Year and the Mothers Against Drunk Driving Award, just to name a few. Colonel Bond was also recognized as a YMCA Black Achiever for his accomplishments in Law Enforcement. In addition, Colonel Bond was the recipient of the 2014 Law Enforcement Officer of the Year by the Psi Iota Chapter of Omega Phi Psi Fraternity, Incorporated.

Colonel Bond earned a Bachelor of Science degree in Psychology from the Delaware State University in 1991, and it was there that Bro. Bond was initiated into the Omega Psi Phi Fraternity, Inc. through the Psi Epsilon Chapter in spring 1988. He has received over 2000 hours of specialized professional training such as West Point Command and Leadership Academy and the Senior Management Institute for Police Executives.

In speaking with Chief Bond, he indicated that he was humbled to be named to the chief position and that he was grateful for those that paved the way for him to reach this milestone in his career. He is proud to hold the mantle for other minority officers. When asked about his biggest challenges, Bond cited the need for the Division of Police to develop a plan to instill trust between the communities of New Castle County (DE) and policemen. Additionally, he alluded to the fact that the division must develop and implement strategies to attract a diverse workforce.

Colonel Bond is a member of the Delaware Chapter of the National Organization of Black Law Enforcement Executive and a Board member of the National Alliance on Mental Illness.

Bro. Colonel Bond is an active member of Psi Iota Chapter of Omega Phi Psi Fraternity located in Dover, Delaware and serves on the Usher Board at Bethel African Methodist Episcopal Church in Wilmington, Delaware. Colonel Vaughn M. Bond Jr. has been married to his wife, Darlene for 22 years, and they have two daughters, Jasmine, a freshman at Norfolk State University and Jada, a high school sophomore.

## Physicians' Corner - Cancer and Its Impact on African American Men

Brothers,

In this episode of the Omega Physician's Corner, we will be discussing cancer and its impact on African American men. The most common cancers that affect African-American men are prostate, lung, colon and rectal cancers. African-Americans have the highest cancer death rate and shortest cancer survival time of any racial or ethnic group in the United States. African-American men have the highest prostate cancer rates of any group. African-American men are twice more likely to die from prostate cancer than their white counterparts. African-Americans have the highest incidence of colorectal cancer in the United States. African-Americans also have the highest death rates amongst those impacted by colorectal cancers. African-Americans are more likely to be diagnosed with more advanced colorectal cancer. African Americans are less likely to have colonoscopy screening. Lung cancer is the second most common cancer in African-Americans. African-American men have higher rates of lung cancer than white man. Lung cancer is the leading cause of cancer death in African-Americans. There appears to be multiple contributing factors to these statistics that demonstrate the heavy burden that the African American community bears when he comes to these cancers. As I mentioned in my previous articles "Prevention is less costly to us then reaction". There is no medical issue where this is so evident other than these screenable cancers (prostate/colorectal/ lung). What can we do to put ourselves in the best situation when it comes to preventing cancer and/or identifying it early? Of course there are some basic lifestyle recommendations. These recommendations include avoidance of tobacco products and smoking. Maintaining a healthy weight through diet and exercise. Staying physically active through exercise. Consuming a healthy diet. And most importantly having your scheduled recommended screening test done. The screening test are best initiated through your primary care physician. I will provide some basic information pertaining to these cancers and their recommendations for screening. This should not be in place of you seeing your doctor and having a conversation with your doctor. Lung cancer— It is recommended to have an annual screening for lung cancer if you are an adult between the ages of 55 and 80 years old who has a 30 or greater-pack-year history of smoking or have quit smoking within the past 15 years. The recommended test is a low dose CAT scan of the chest without contrast.

Prostate Cancer— It is recommended that African-American man started having there screening at the age of 45 years old (It can start earlier if your medical history suggests). That screening will include prostate specific antigen (PSA) blood test and a digital rectal exam. This should be done annually.

Colorectal Cancer— The latest guidelines recommend African-American men having their first colorectal screening test done at the age of 45. The goal standard is the colonoscopy. They are some alternatives that can be done if one is apprehensive about having a colonoscopy done. If these alternative tests do show a positive result then the patient must have a colonoscopy to follow-up. The results of the colonoscopy will dictate the frequency that the subsequent surveillance colonoscopy should be done. If one chooses to have the other test in place of the colonoscopy, then those tests should be done annually and as stated earlier if the result is positive then that patient should have a colonoscopy.

A significant contributor to the cancer burden stated above is our lack of having scheduled screening tests done. These tests are done to try to catch these cancers as early as possible. If a cancer is diagnosed at an early stage then the treatment is less impactful on the patient. Again my brothers all of this starts with you seeing your doctor and having these conversations about the different components that go in to you maintaining your health. So my brothers remember prevention is a lot less costly to you then reaction when he comes to your medical care especially will be talk about cancer.

### Joint Statement on Hazing in Response to the Movie Burning Sands

NPHC is comprised of local councils drawn from the ranks of 1.5 million college and professional members of the nine historically African-American fraternities and sororities, namely: Alpha Phi Alpha Fraternity, Inc., Alpha Kappa Alpha Sorority, Inc., Kappa Alpha Psi Fraternity, Inc., Omega Psi Phi Fraternity, Inc., Delta Sigma Theta Sorority, Inc., Phi Beta Sigma Fraternity, Inc., Zeta Phi Beta Sorority, Inc., Sigma Gamma Rho Sorority, Inc., and Iota Phi Theta Fraternity, Inc., and the Council of Presidents of these member organizations who come together on issues that promote the common purposes and general good for which these organizations exist.

In 1990, the NPHC organizations issued a joint statement announcing the elimination of pledging and each has instituted within its respective organization, a revised membership development and intake process.

Each NPHC organization has instituted strong policies against hazing and has taken steps to reinforce and strengthen their stand against prohibited conduct whether it is displayed through movies, books, or any type of social media.

Equally important, NPHC and its member organizations do not condone, support, or encourage the production of movies, books, or any type of social media that promote hazing.



## “Burning Sands” Movie Review



The movie “Burning Sands” directed and produced by Omega Psi Phi Fraternity member Gerard McMurray (Alpha chapter 2002) is a dark drama about Black collegiate fraternity life and in particular Intake into a Black frat. It revolves around the fictitious fraternity, Lambda Lambda Phi. The movie’s backdrop is on an unnamed HBCU campus in a sleepy southern town. The film exposes much of the violence that is endemic in pledging a Black Greek lettered fraternity. It delves into the societal acceptance and dangers of pledging from multiple levels. The movie examines the “code of silence” maintained by the fraternity’s members, potential members, campus advisor, alum, students and even a faculty member. While there are some aspects that resemble Omega Psi Phi, Fraternity there is no actual connection to Omega. It could have been about any Black Greek lettered fraternity. The value in this film is the potential to create dialogue that can stimulate genuine results on how BGLOs deal with the problem of violence.

I know my views may not be popular with the membership of Omega Psi Phi Fraternity but the movie was fairly accurate. I also know many from my era will agree that is not how we pledged. We spent far more time pledging than getting hazed in the 70’s & 80’s. There is no place in Omega from what I saw in “Burning Sands” but the reality is it exists. In the scene where the main character and intake member Zurich meets with the character Dean Richardson the chapter’s advisor the conversation was all too real. It was an effective example of how older fraternity members sometimes perpetuate and re-enforce the inhumanity of hazing by denying its presence.

In this film there were no secrets of Omega betrayed. No indiscretions. Nowadays “Bruhs” view anything that if caught and it gets you into trouble as indiscrete. A “GDI” could have written the screenplay. The more we pretend like the public doesn’t know who we are and what we do the more our own denial becomes our greatest potential for harm. In 1980 my line’s “last meal” of Alpo dog food was in the cafeteria during “Hell Week” for all to behold. It had been done that way probably since Hell Week came into being on our campus. Yet, that also became a part of the underground. So when pledging went underground the underground part of pledging that was always there is all that was left. And that was the “SET”.

This film creates the potential for a narrative that all members of the D9 can relate to. It is not just an Omega problem. This movie doesn’t singu-

larly indict Omega Psi Phi Fraternity but all BGLOs. And it highlights a major systemic issue that has been swept under the rug by BGLOs, colleges and universities and that is the tendency not to deal with it in a realistic manner. As far as Omega is concerned the culture of violence is likely the source and cause of a cancer in our organization. I would say it has much to do with our often times lack of discretion, occasional gross dereliction of proper care during intake, super low retention numbers, a culture that resembles gang like associations among chapters and an internal violence that has a tendency of spontaneous combustibility which are all telltale signs. It can even be concluded that the random violence we sometimes witness at informal Omega gatherings has a direct correlation to our “process”.

As Omega men we are members of the greatest Black Fraternity on the planet. We must embrace the underlying theme of “Burning Sands” as quoted by Alfre Woodard’s character in the film, which is one of Frederick Douglass’ most famous quotes: “It is easier to build strong children than to repair broken men”. The sort of hazing witnessed in the film Burning Sands demonstrably strips young people of their dignity and frequently places them unnecessarily in harms way. I submit to those who would say this film is not important or holds no value because we have greater issues in Omega that ignoring this film and not recognizing the golden jewel of reformation and restoration it presents is a major mistake and a failing we can ill afford.

**Annapolis, MD. February 14 and March 2, 2017.** The 2nd District of Omega Psi Phi Fraternity, Inc., provided support to Delegate Pamela E. Queen, Legislative District 14, Montgomery County at the Economic Committee Hearing. 2nd District, Fatherhood and Mentoring Committee provided assistance to Delegate Queens' proposed legislation : 1) House Bill #459 – Higher Education - Adult Correctional Institutions – Job Training and Education Bill for establishing a training program for returning citizen; 2) House Bill #847 – Expansion of Prescription Medication for Released Inmates bill – Benefits for Individuals Who are Incarcerated or Institutionalized. Delegate Queen was appreciative for lending our voice in efforts to provide inmates with workforce training, certification and experience for “in demand” job sectors.

The 2nd District of Omega Psi Phi Fraternity, Inc., fully supports these proposed bills aims to provide assistance to incarcerated men and women that transition back to the community. They also allow approval for future release for certain inmates in the process of applying for Medicaid or health coverage through Maryland Healthcare Marketplace.

Brother Jeffrey Diggs, Basileus, Mu Rho Chapter, supported the Fatherhood and Mentoring Committee at the Judicial Hearing by providing testimony to the House Bill #847. Mu Rho Chapter located in Annapolis, Maryland mentors some fathers from their Adult Fathers Mentoring program who were ex-offenders. Some have successfully re-established themselves back into society. Brother Diggs shared how fraternity members work closely with the Department of Social Services (DSS) to help the fathers discover their confidence, niche in life, employment training, employment, assess individual and family needs linking men to services. The mentoring program includes an array of health and human services such as, individual and group counseling, literacy, assessment of reading levels, life skills, employment opportunities, and one-on-one tutoring and family management counseling for children, teens, adults and families.

As a result of this new Legislative Focus experience, we request volunteers to form a Legislative Sub-committee. The purpose of the sub-committee will be to track and monitor Legislative House Bills that impact Adult Fathers and Young Males. To make recommendation to Fatherhood and Mentoring Program Chairman to be vetted to District Executive Team. Please contact FMP Chairman to join this new sub-committee.

# International Talent Hunt Foundation, Inc.

In 2006, the International Talent Hunt Committee (ITHC) held its first retreat in Atlanta, Georgia. Meetings were held at the International Headquarters (IHQ) in the Supreme Council Conference Room, where 9 of 12 District Talent Hunt Chairmen were in attendance, along with the chairman and vice chairman of the ITHC and the Assistant Director of Operations at IHQ.

During the weekend of our retreat, there was great deal of discussion about the International Talent Hunt Guidelines and other concerns and issues, as well as ways to enhance our Talent Hunt efforts. A major point of conversation was ways to enhance funding for our International Talent Hunt Program. It was recommended that we establish a 501(c)(3) foundation focused on promoting the arts and advancing the artistic opportunities for our young people.

After a series of conference calls and written correspondences, it was decided to make a recommendation to the Grand Conclave to create a Talent Hunt non-profit organization. That recommendation was submitted for consideration on April 21, 2010. It was at the 77th Grand Conclave in Raleigh, NC that the Conclave delegation approved the establishment of a foundation to support the visual and performing arts endeavors of the ITHC, a separate body with no input into the operation of the foundation. The official name of the organization is the International Talent Hunt Foundation, Inc.(ITHF), which was approved by the Internal Rev-

enue Service as a 501(c)(3) organization in December 2014.

Since its establishment, the ITHF has created by-laws to govern its work, selected 10 board members with tiered terms, developed an informational/donor brochure, signed a licensing and branding agreement with OPPE, Inc., convened for its inaugural NV, and held a silent auction of some prints of famous athletes – Michael Jordan, Steve McNair, Alonzo Mourning, Shaquille O’Neal, and Charlie Ward. Plans are in the works to enhance its fundraising efforts to include an individual giving campaign. The ITHF was formed to support the International Talent Hunt Program. The hope is to eventually offer financial support to chapters for visual and performing arts programming for young people.

As a part of your charitable giving for 2017, the ITHF requests that you consider a contribution for the uplift of our gifted and artistically talented young people. Your donation will support the foundation with providing resources and opportunities for our young people who participate in the International Talent Hunt Demonstration (ITHD). The ITHD is now every year due to the efforts of the International Talent Hunt Committee that lobbied the Conclave to approve the demonstration as an annual event. Brothers that provided significant testimonies were: Honorable renowned and distinguished Judge Arthur Burnett, Washington, DC 3rd District; joined by Frank Malone, Co Commissioner, Office of the Mayor, Washington, DC, Commission on Black Men & Boys; CEO of Hundred (100) Fathers, Inc., Washington, DC 3rd District; and Thabiti Boone, former President Obama White House Representative. Standing in support Brothers Jeffrey Diggs, Mu Rho Basileus and member of 2nd District Fatherhood and Mentoring Committee. Also, the Right Reverend Brother Courtney Miller, 3rd District Chaplain.

Far too many Fathers are continually challenged with receiving minimal time and access to their children. One of the biggest "barriers" to father's time with their children, are laws and policies set by political officials, which are enforced and promoted by Family Courts. **New York, New York . March 2017.** Since its inception in 1986, the Omega Black College Tour has become arguably one of Omega Psi Phi Fraternity's most successful and recognized programs. The Omega Black College Tour program identifies and prepares students of color for visitation and academic review of Historically Black Colleges and Universities and, ultimately for leadership roles in our society. Partnering with tristate area high schools, community organizations, non-profit foundations and state agencies, the program introduces a multitude of students, eager to learn about higher education opportunities, to college admissions administrators from the campuses of Historically Black Colleges and Universities.

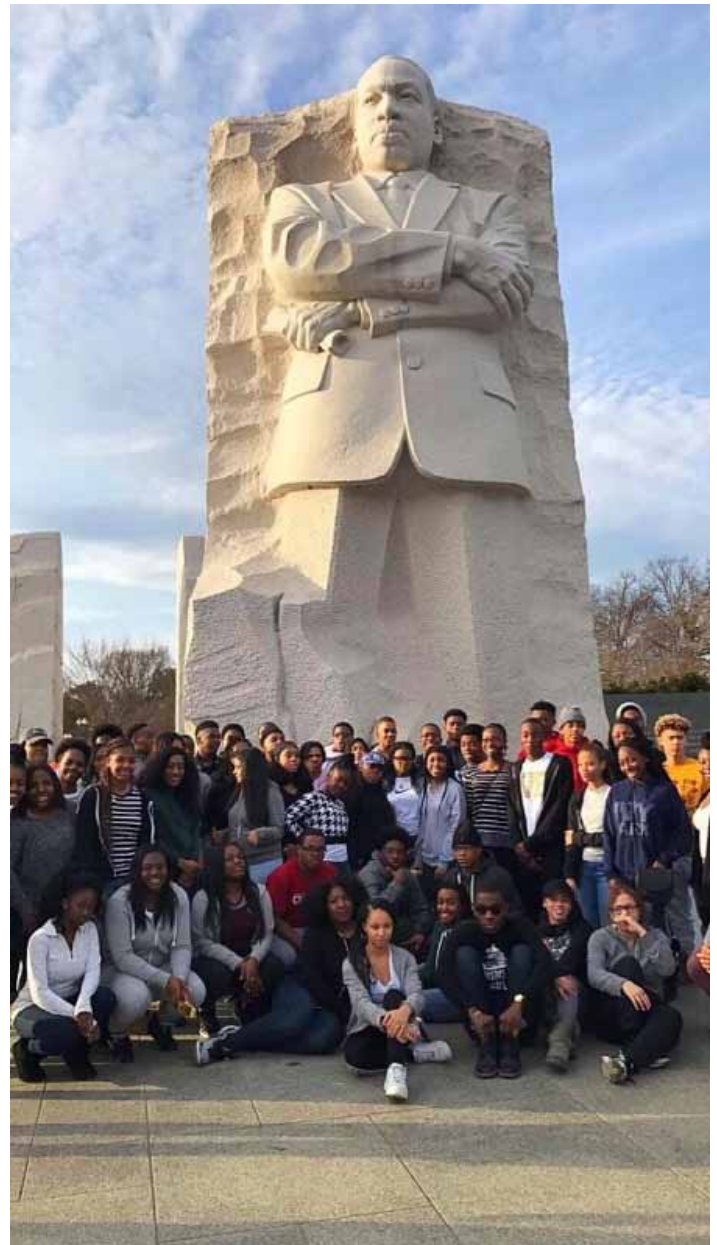
Omega Black College Tour students come from 2nd District households throughout New York City's five boroughs, New Jersey, Westchester, and Connecticut. Our comprehensive approach begins with an aggressive, citywide student talent search in which roughly between 300 to 500 nominated youngsters are selected for approximately 50 seats. The selected students complete a five-weekend workshop program which includes two parental workshop sessions. During the tour students' academic portfolios are presented to admissions administrators and students who successfully meets the college's or university's highest standards often earn on-the-spot admission offers from some of the nation's top such as Howard University, Hampton University, Spelman College, Morehouse College, North Carolina A&T University, Clark-Atlanta University, Norfolk State University, Morgan University, North Carolina Central University, Delaware State University and University of Maryland Eastern Shore. Many of the 2017 senior student scholars were accepted to one or more HBCU's.

Students who attended this year's college tour workshops were also able to draw inspiration from Bronx District Attorney Darcel Denise Clark, New York's first African-American female DA and a Howard University graduate. DA Clark reinforced the relationship between hard work, seeking opportunities and community support. These fundamentals align with the lifelong impact of our fraternity's Cardinal Principals. Particularly for the hard-working students who, through circumstances beyond their control, need a little extra help to reach their goals.

The program has proudly reached the stage where Omega Black College Tour alumni consistently take immediate advantage of the robust academic lessons learned during the Omega BCT workshops. 2016 Omega BCT alum Naliah Wright, a Staton Scholarship recipient and current freshman at Hampton University is a wonderful example. She writes "to those who donate, you turn dreamers into achievers, and turn hopeless thoughts to hope. I would not be at Hampton without the men of Xi Phi Chapter, the Omega Black College Tour and its supporters. I made the Dean's List this year as a freshman and plan to do even better as a sophomore – I will continue to make you proud."

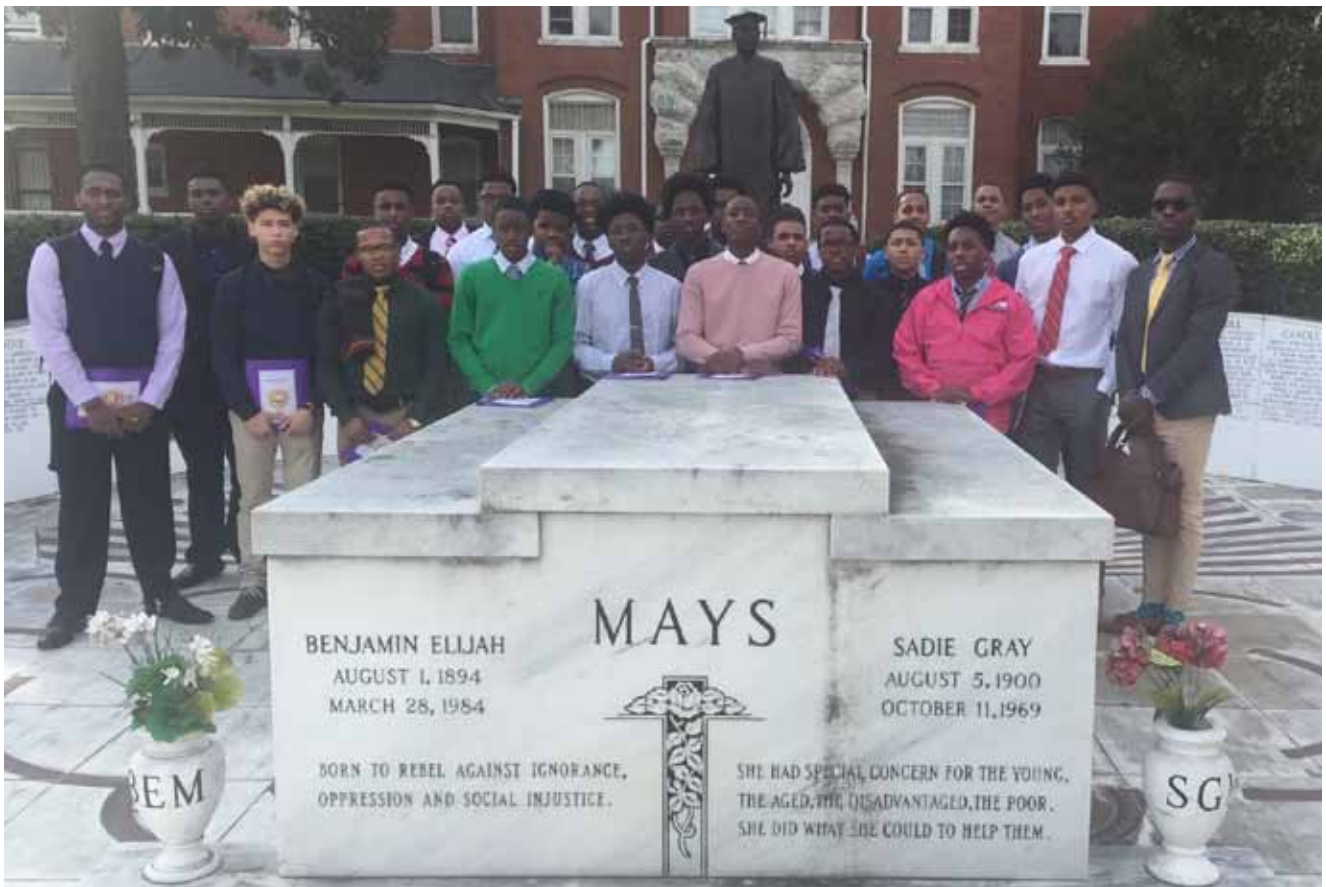

Charles began his legal career as a prosecutor in the Kings County (Brooklyn, NY) District Attorney's Office. While there, he excelled quickly and was hand-picked to join the specialized Gangs Unit where he prosecuted some of the city's most dangerous and violent criminals in several high-profile cases.

Since leaving the DA's office, Charles has since transitioned to the arena of civil rights, focusing primarily on Equal Employment Opportunity law while helping to advance the conversation on race, culture as well as to promote the interests of diversity and inclusion as a bridge to greater understanding. In keeping with his focus on civil rights, Charles has also leveraged his powerful voice to speak out in addressing issues related to social justice. ## Xi Lambda Lambda Rockland Person of the Year

**Rockland County, NY. March 2017.** Wylene Branton Wood is a lifelong educator, who as a teacher and volunteer has involved herself in activities to promote education, social justice and equality. Born in Pine Bluff, Arkansas, Wylene grew up in a family and a community involved in calling for justice and battling segregation. She spent her teen years in Atlanta, Georgia, and in Washington, DC.

She received her bachelor's degree from Spelman College in Atlanta in 1971 and a graduate degree in English Language and Literature from the University of Chicago. She began a 32 year teaching career at TV College, a part of Chicago City Colleges. Later, she taught for the Los Angeles Unified School District and then for LA Southwest College and Los Angeles Trade Technical College, where she achieved the rank of professor. Moving east, she taught at Montgomery College in Rockville, Maryland, and upon moving to Morris County, NJ, she taught for the Mount Olive School District, where she remained for seventeen years until her retirement from active teaching in 2004.

Her post-retirement years have been spent in Rockland County, NY, where she has continued her commitment to education by coordinating major educational and cultural events for the Rockland County community, especially for its youth. On behalf of the African American Historical Society of Rockland County, she was Co-Chair of the Amistad Visit to Haverstraw and Coordinator of the A Mighty River programming for

2009 and 2010. In 2011 she coordinated programming for IndiVisible: African-Native American Lives in the Americas," programming to celebrate and enhance the visiting exhibit from the Smithsonian National Museum of the American Indian; in 2012 she orchestrated "Changemakers: Songs and Images of the Civil Rights Movement"; in 2013 for she interviewed key veterans of the 1960's Civil Rights Movement and coordinated "The Vote in America: Struggle, Challenge and Change; and in 2014 she scripted and organized a program called "A Glimpse of the Harlem Renaissance." In 2015 the program she coordinated was entitled "I, Too, Sing America: The Contributions and Challenges of African Americans in the US Military (Part I—American Revolution to World War II). This program featured interviews with noted Veterans such as General Colin Powell, Sergeant Sanders Matthews, Dr. Olivia Hooker and Dr. Roscoe Brown. (These interviews have even greater significance now as Mr. Matthews and Dr. Brown both, unfortunately, passed away in recent months.) Then, in 2016 Wylene orchestrated "The Gift of Music," highlighting the musical contributions of Black people from classical to spirituals, from ragtime to jazz. (It was due to the interest in and curiosity about spirituals that the theme for 2017's program was selected: "A Faithful Journey: The American Negro Spiritual," featuring RCC Performing Arts students and alumni and Opera Noire of New York.)

Wylene's vision created these multi-disciplinary events on behalf of the African American Historical Society of Rockland County and in partnership with Rockland Community College and the RCC Performing Arts Department and early on with The CEJES Institute and the Rockland African Diaspora Heritage Center. The programs, offered free each February, have been made possible by generous grants from community-minded entities and have been presented each year to 500 or more students from schools across Rockland County as well as to hundreds of individuals from the community-at-large.

A supporter of the Nyack and Spring Valley NAACP organizations, Wylene also serves on the Board of Directors of VCS, Inc., where she is fulfilling her third term as President. Additionally, she served as President of the Board of Trustees of the African American Historical Society of Rockland County for 10 years as well as Co-President in 2016. A poet, writer, and frequent guest speaker, Wylene has received recognition and awards from numerous organizations including being inducted into the Rockland County Civil Rights Hall of Fame. In June of this year she and her husband, Dr. Cliff L. Wood, will celebrate 30 years of marriage. They are proud of their four grown children, their in-laws and five amazing grand-children.

## Kappa Chapter at Dedication of New NPHC Bench on Quad at Syracuse University

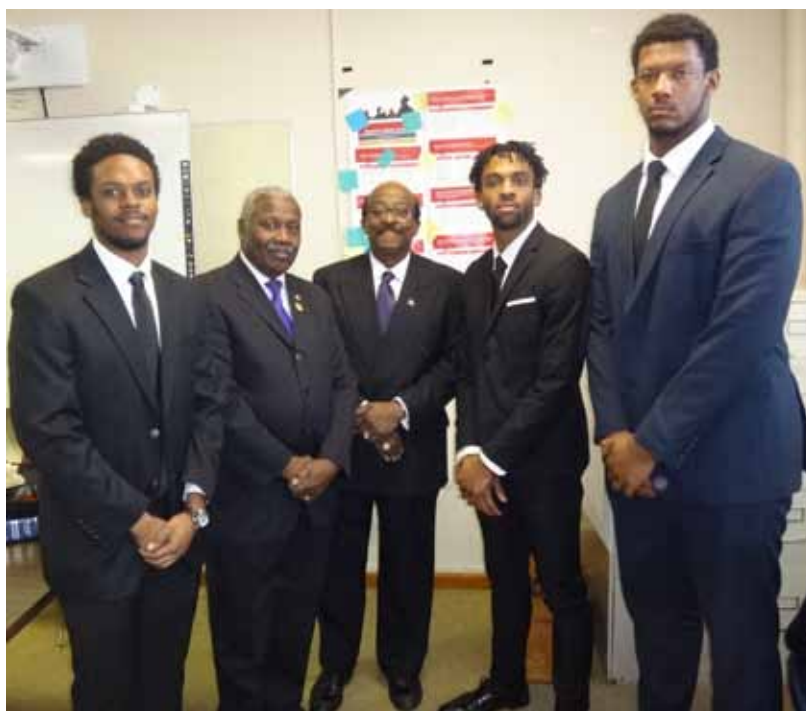

In 2013, The Omicron Chi chapter of Omega Psi Phi Fraternity, Inc. established The Omega Leadership Institute (OLI) to provide college bound African-American males (14-18 years old) in the Union County and Central New Jersey region with the encouragement, leadership skills, and support to make meaningful contributions to their communities. Through the intensive leadership development sessions, the OLI exposes student participants to higher education and includes motivational speakers, leadership exercises, small group sessions, interactive workshops, and access to business professionals and community leaders. The program is conducted

in the Spring of each year and consists of a 10 week life-skills curriculum developed and administered by the members of Omicron Chi Chapter and external partners.

The Spring 2017 OLI Cohort's theme is "Doing the Right Things Right" and will focus on Leadership Development skills including Decision Making, Character, Morals, and Community. The Spring 2017 Cohort includes workshops like: Personal Branding, Defining Values, Morals and Ethics, Decision Making, Teens and the Law and Ethics in Business/ The Brothers of Omicron Chi Chapter have made it an imperative to develop the next generation of African-American Male leaders for the public, private, non-profit, and entrepreneurial sectors. The Men of the "Mighty OX" support the Omega Psi Phi Fraternity's national "Fatherhood Initiative" and President Barack Obama's "My Brother's Keeper (MBK) Foundation's efforts. Omicron Chi Chapter's Basileus, Brother Leon Smith II states "when scholars leave the OLI program, they are more energized to become involved in their schools and communities and are more tolerant and open-minded of those around them." OLI Scholars have shared that they have a focus on their future and a vision for transformational impact on our communities.

## Brother Dr. Walter A. H. Gill Pens Autobiography “Yesterday’s Tomorrow”

**Baltimore, MD. September 2016.** Yesterday’s Tomorrow is Walter Gill’s autobiographical depiction of family’s survival in the Black Diaspora of the 1930’s to the still defacto segregation of today. It speaks of one family’s journey, using the green book, to survive the drive in the Jim Crow South, moving from town to town for a father’s employment to support his family, teaching at different HBCU’s. Fraternally, it is the Father to Son legacy story: Father, Dr. Robert Gill, a Giant in Omega, PhD, author of the History of the Fraternity, well traveled, taught Tuskegee Airmen, highly accomplished educator and Son, PhD, well traveled, accomplished author, educator and artist.

It tells how Omega Men employed at Morgan State College, in the 40’s to 70’s, were dominate in all aspects of administration on the College and how Omega and Omega men influenced and continue to be significant in Walter’s life. He chronicles his friendships with fraternity Brothers who became giants in their respective fields, such as Lonnie Liston Smith, musician, Earl Graves, publisher Black Enterprise and The Honorable George K. McKinney, the first African American to be appointed U.S. Marshal for the District of Maryland, and whose career in federal service spanned more than four decades and served President Nixon on a subpoena to turn over White House tapes relating to the Watergate scandal. It documents Walter’s family life through historical events with relative ease, while telling the effects of each life experience, making him to be one of the true great spirits of our time. It is the story of loves, loves lost and finally finding one true love. This is a great African American history lesson of a great lifewith an emphasis on education is the key to a great life. A must read. Brother Dr. Walter A. H. Gill was initiated in 1957 through Pi Chapter and is currently a memembr of Pi Omega Chapter.

### *The Urban Professor*

Walter Gill is a teacher, author, artist, actor and former university professor. Born in Greenville, Mississippi, he attended public schools in Jefferson City, Missouri and Baltimore, Maryland. He was the first African American to graduate from Baltimore City College High School in 1955 and is a member of the school’s Hall of Fame. He graduated from Morgan State College (now University), and received his Masters and Ph.D. degrees from Syracuse University in educational communications.

For 22 years he was a university administrator or professor which included employment at Bowie State University (MD), Morgan State University (MD) and the University of Nebraska at Omaha where he was recommended for tenure. Dr. Gill has spent 26 years with children and youth as an art and social studies teacher, counselor for at-risk youth and delinquent males, director of a boys club, a year-long project for inner-city African American middle school males, and as a social worker in foster care. Seventeen years were spent with adjudicated and delinquent youth in three states.

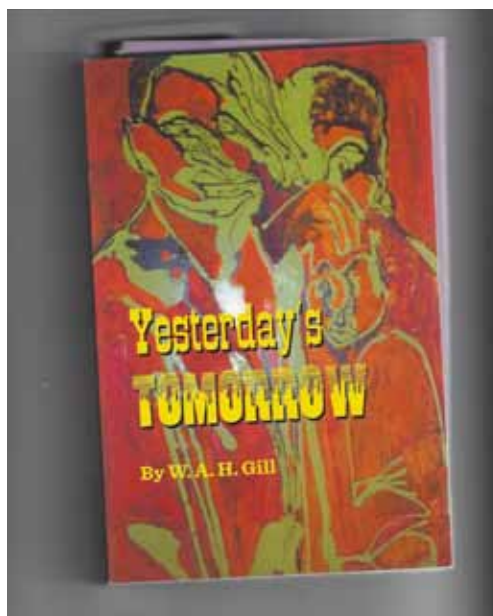
As an artist, he has engaged in painting, collages, crafts, ceramics, photography, films, clothing design, and acted in community theatre. He received a Best Supporting Actor Award from Center Stage for his portrayal of “Getlow” in Purlie; and Best Actor in a Musical or Comedy as “Lucian” in The Boys Next Door, from the Omaha (NE) Community Playhouse. He had a brief part in a Homicide: Life on the Streets episode.

Dr. Gill has authored the forementioned autobiography, Yesterday’s Tomorrow, three books on urban education: Teaching in Urban America: A Formula for Change; Issues in African American Education (1991) and A Common Sense Guide to Non-traditional Urban Education (1997); and A. Frances Nichols Gill Family Pictorial History. Gill was one of three reviewers for the Islamic publication By Dawns Early Light.

As an urban educator, Dr. Gill has excelled with hard-to-reach, challenged and delinquent males as documented on film, television and in newspapers. He is an adjunct professor at Towson University (Maryland) in the Department of Early Childhood Education and teaches two sections of “Teaching and Learning in a Diverse Society.”

Dr. Gill also advocates for children in foster care: he was appointed by the Governor of Maryland to serve on the Citizens Review Board for Children for the Baltimore City, Department of Social Services; and he is President of the Governing Board of Seraaj Family Homes, Inc. headquartered in Montgomery, Alabama with six offices, and offices in Omaha, Nebraska, Washington, D.C., Riverdale and Baltimore, Maryland. Dr. Gill attempts to live in the image of his father, Dr. Robert L. Gill, author of The History of the Omega Psi Phi Fraternity and the Men Who Made Its History. His mother Rubye Harris a scholar-athletic-music teacher and community activist was key to his interest in the arts. He also designed and promotes the “I Love Baltimore – The Harbor City” tee shirts.

His Islamic name is Wali Hakeen, meaning “wise friend,” a characteristic he believes all teachers should be to their students. He can be reached at urbanprofessor@aol.com.

### A Call to Uphold the Ritualistic Standards of Our Beloved Fraternity

Over the years I have witnessed a troubling degradation of the high ideals and standards of Omega Psi Phi, which I believe is the result of an ad hoc proliferation of local customs that is leading to secularization of our organization. From chapter to chapter and district to district the evidence of non-standard practices is visible in many, many areas, but nowhere is it more pronounced than in our most sacred ceremonies, which are the Initiation, the Memorial Service and the Omega Service.

For example, in the conduct of the Omega Service, our most sacred ceremony, many chapters have taken to infusing their own "local customs" in how this Ritualistic duty is carried out. The dress code is not strictly enforced, songs other than Precious Lord are included, poems such as

"When We Wear the Gloves" and other such deviations have become routine. It is equally troubling when Brothers show up at other sacred ceremonies like our Memorial Services improperly attired and yet they are allowed to participate and are included in Official Omega photographs.

While some of these renditions are "nice touches" and pleasing to behold, especially "When We Wear The Gloves" my personal favorite, unfortunately they are not in compliance with the Ritual, the Policy and Procedures Manual, the Protocol Handbook or other sanctioned documents. With the Fraternity being some 106 years old, evolution is not only inevitable, but it is expected. Fortunately we have been given the tools, mechanisms and processes to allow for adaptation of change. Those tools include our ability to propose recommendations to our Constitution and By-Laws, and to make revisions to the Policy and Procedures Manual, through proper channels. Once those recommendations are adopted and published, we will then have a standard by which we can operate. Brothers, I feel that our Founders only required three Sacred Ritual Ceremonies which are the Initiation, an annual Memorial Service and an OMEGA Service and I would ask that we do all in our power to maintain the sanctity, tradition and standardization of these events. Let us go through the proper channels before blindly accepting derivations to the most sacred of our traditions, lest we lose the sense of importance and value of our Ritual.

Many of us cringe when we look at today's status quo behavior, tongue wagging, violence and brutality of Brother on Brother incidents, greening, hazing, "Betty Crocker" challenges, and indiscretions in public behavior. We have allowed our standards to slip in many areas; I just want us to preserve some sense of tradition in our Ritualistic mandates. It's really all that we have left, as we strive to uphold the promise that our Founders made to Dean Kelly Miller that we "would be like-minded men to them and uphold the high ideals and standards, ad-infinity".

### History Is A Beautiful Thing

A few years ago, I asked 39th Grand Basileus, Brother Dr. Andrew Ray to sign my Omega history book. We engaged in a five minute conversation concerning the current state of Omega history. Brother Grand Dr. Ray stated "If you do not write your history, someone else will write if for you"! I never forgot those words and being a history enthusiast, it motivated me to seek additional history and knowledge.

During the past few years, I have audio- and video-recorded numerous public forums in which 28th Grand Basileus James Avery and 39th Grand Basileus Dr. Andrew Ray spoke to our Brotherhood. I hope to submit those recordings to our District and National offices so they can be placed in our historic archives. My Undergraduate Chapter (Kappa Eta Chapter, founded in 1975 at Seton Hall University in South Orange, New Jersey) just celebrated its 40th Anniversary. During the planning stages of our Anniversary Weekend Celebration, I volunteered to chronicle a Chapter history book. Many of the Chapter Brothers were excited and stated they would contribute in whatever ways they could. I asked Brothers to find their line pictures, flyers and any public documentation concerning the Chapter. Some Brothers scanned in pictures and emailed their information to me. I found out that many of the Brothers who pledged in the early '70's were not computer savvy; they had information which I could use, but could not get it to me via "electronic" medium. I decided to purchase a portable handheld scanner (approx. cost \$50), met my non-computer savvy brethren at various locations (their homes, restaurants or bars) and scanned in the pictures and documents they wanted to contribute to the history book. As we fellowshiped, I scanned in pictures, discussed the climate of various universities who were concerned with subjects like the Black Power moment and our Fraternity's Chapter on their campus. I also found out that some Brothers were involved in campus sit-ins and protest rallies at various locations. Some Brothers were even arrested during those activities.

Another Brother mentioned that there were many school officials (some black, some white) who did not want the Brothers to have a Chapter at Seton Hall University. Brother Joseph Rouse (Kappa Eta Chapter, '75) stated "There would be no Kappa Eta Chapter if Monsignor Thomas Fahy, Ph.D. Seton Hall University President 1970-1976 did not stand in line with our Brothers to obtain the Chapter". As I continued to receive various pictures of large afros, thick sideburns (and coke bottle-shaped sweethearts and sisters of Delta Sigma Theta Sorority), I started to wonder where those Omega Brothers of the 70's might be. Some of them I'd have met and others have entered Omega Chapter but many others? Their whereabouts are currently "unknown". As I began to produce hard copies of the draft of the history book, I would travel to various Fraternity Chapter meetings and events and display portions of my chronicle; I would witness the excitement in the eyes of our Brothers as they saw their names in the book. As I continued to display the book, I'd recruit additional Brothers to submit information as well as corrections. I made several revisions and additions including pledge lines prior to Kappa Eta Chapter, the Omega Memorial Services, 13th, 21st, 25th, 30th and 40th Anniversary pictures and documents. I also created several two minute video presentations of which Brother Steve Barnes (Iota Eta Chapter, 1970) discussed the first undergraduate line in the state and campus, political and social issues in the early '70's. ## Psi Iota Takes a Stand Against Domestic Violence

**Dover, DE. October 11, 2016.** The Brothers of Psi Iota took part in the proclamation signing by the Governor of Delaware, Jack A. Markell, in conjunction with the Domestic Violence Coordinating Council (DVCC) and the Delaware Coalition Against Domestic Violence.

The DVCC tracks domestic violence-related deaths that occur throughout the State of Delaware. These domestic violence-related deaths include victims, perpetrators, or by-standers if the death was a result of domestic violence, either intimate partner violence or between family members.

Between 1996 and 2015 in the state of Delaware, there were a total of 112 domestic violence-related homicide victims. The leading cause of the homicide was via a stabbing of the girlfriend or wife of the offender. According to the National Domestic Violence Hotline, female intimate partners are more likely to be murdered with a firearm than all other means combined. However, in Delaware during 2015, there was one homicide victim

killed by gunshot which is unusual when compared to previous years.

A more alarming fact is that domestic violence affects our children as well. Statistics shows that 122 children lost a parent to domestic violence homicide and two children were impacted by near death of a parent.

Following the proclamation signing, The Brothers of Psi Iota took it one step further and went to social media to show how important it is to bring awareness to stop domestic violence. The Brothers took to social media posting pictures with the caption, "I am an Omega and I stand up and speak out against domestic violence."

**Dover, Delaware. February 23, 2016.** The Brothers of Psi Iota Chapter of Omega Psi Phi Fraternity, Inc. partnered with Wesley College, 50k Souls and Pastor Carlos Cannon to provide water to those that are in the heart of the water crisis in Flint, Michigan.

Many of us cannot imagine turning on a water faucet but not having clean, drinkable water. However, this is the reality for the residents in Flint. Flint is located 70 miles north of Detroit, where close to half of its residents live below the poverty line. The Flint water crisis began in 2014 when the Flint River became the primary source for water. The issue is that this water supply has historically been tainted and was never cleaned prior to becoming the main water source.

A cry for help came from our brothers and sisters in Flint. They were warned that the water contained byproducts of disinfectants that may

cause health issues. The residents of Flint needed our help and Psi Iota answered the call.

A GoFundMe account was set up by Psi Iota Chapter to help raise money for the people of Flint, Michigan. The goal was to take the money raised and buy two pallets of water to be transported to Flint, Michigan. With the assistance from Wesley College, 50k Souls and Pastor Carlos Cannon, the water was purchased and put on a tractor trailer to be transported. In total, 147 cases of water were purchased, packaged and sent to the citizens of Flint.

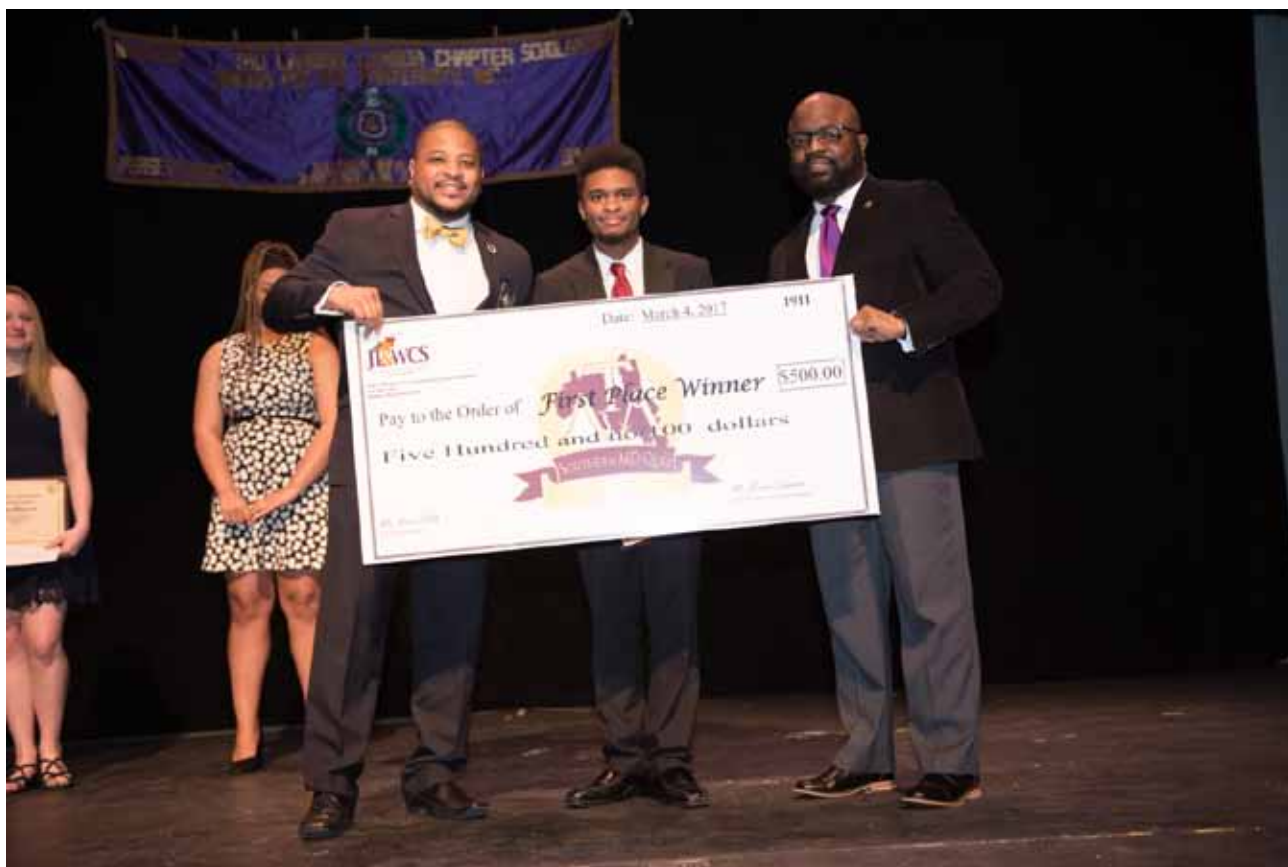

## Gamma Pi Project ENRICH

January 21, 2016.** When it comes to working with young people, the Brothers of Gamma Pi Chapter enjoy sharing their knowledge and connecting young students with mentors and others who can help them chart a course to success. That philosophy is most evident in Gamma Pi's Project ENRICH program that meets monthly at Bowie State University and was on display Saturday, January 21, during a careers presentation.

In a different twist this year, Project ENRICH director Bro. Willie Hines arranged for students to hear from just two presenters for Career Day. The focus this year was on entrepreneurship. In featuring just two professionals, Project ENRICH was able to turn the spotlight on business ownership rather than type of occupation.

Brother Anthony Stewart connected quickly and directly with students when he "got real" and told them that his success today was a direct contrast to his rural farm upbringing on Maryland's Eastern Shore. He talked openly about his status as the lowest-performing child academically among nine siblings in the household. "Everybody in my family has a graduate degree and they all graduated Magna Cum Laude and Summa Cum Laude and I graduated, 'Thank you Lawdy.' I barely got out of here" (Bowie State, 1985), he said to laughs from the full auditorium.

Brother Stewart, owner of Stewart Financial Services, Inc., shared his story about how he ambled around early in the years immediately after college not knowing what he really wanted to do with his life. A Business

major, he initially was consumed with becoming a Xerox salesman. He pursued that dream as long as he could – coming "close, but no cigar." He recalled how with a pregnant wife and living in a small condo, he struck out on his own knowing very little about how money works or the financial services industry, but with a strong curiosity and a willingness to learn. He found himself very interested in the topic and it led him to his own financial services business part-time initially and then full-time. To the Project ENRICH students, Brother Stewart's story was an example of a creative way to put your college education to work even if your GPA is not very high. Brother Stewart's main message: "Don't ever chase money; chase your dreams,"

Another presenter, Andrew Clark, from the local area, talked about how he built a successful three-location physical therapy business by stepping away from what seemed like a secure job to take a risk. The stability and solid state of the physical therapy profession was a good building block for him to develop a business.

His overriding message to the youth was to choose a field where demand is high.

Clark, owner of Sports Pro Physical Therapy and Aquatic Center, spent several minutes explaining the academic requirements to become a fully certified physical therapist. He also provided statistics on the demographic makeup of the industry emphasizing that only about 4% of physical therapy professionals are African Americans.

Brother Marquise Findley-Smith (16-IN) led the discussion of the epidemic by first showing a video that illustrated the ways in which women can be abducted, that do not fit the mold of the typical "white van" abductions. Stories of survivors of human trafficking were shared, as well as statistics for human trafficking in Maryland. Several strategies for prevention and reduction in the future were discussed, the most prominent of which included spreading awareness to younger crowds.

# Historical Perspective

## Omega Men in FDR's Black Cabinet

Born of President Franklin D. Roosevelt's "New Deal", the unofficial Black Cabinet was a group of African-American men who worked within the New Deal and had access to the Oval Office. First known as the Federal Council of Negro Affairs, they were an informal group of African-American public policy advisors to President Roosevelt.

Initially, after his election, President Roosevelt, paid little attention to racial issues, focusing instead on the nation's economic crisis. But to enact his relief and recovery programs, Roosevelt needed the backing of Southern members of Congress. Neither he nor his political operatives at first grasped the growing importance of black voters in Northern cities. And although the Roosevelt administration claimed to adhere to non-discriminatory policies, many New Deal programs openly discriminated against blacks.

When he came into office in 1933, the country was just about closed down. There was the feeling that the government had to do something to restore confidence. Roosevelt tried everything he could to get the nation out of the Depression.

Out of this period of massive homelessness came relief from Washington in the form of the "New Deal," a series of economic policies introduced by President Franklin D. Roosevelt after the Great Depression left the U.S. economy in a dismal state. The programs were implemented to provide relief to millions of Americans that were stuck in a state of poverty as a result of the Great Depression. The various programs were rolled out over five years (1933-1938) and covered a range of items including labor, bank, and relief reforms. The New Deal had many opponents, some of whom felt the programs built up the power held by the government and promoted capitalism. And besides, although the Roosevelt administration claimed to adhere to non-discriminatory policies, many New Deal programs openly discriminated against blacks.

Still, as early as the congressional election of 1934, African-American voters were deserting Abraham Lincoln's Republican Party and voting Democratic. Continued migration northward and a sharp reduction in the illiteracy rate among blacks, attributed in part to the New Deal programs, expanded the black electorate which in many cities was reaching critical numbers.

By mid-1935, forty-five African-Americans had positions in cabinet offices and New Deal agencies.

In 1936, this group began calling itself the Federal Council on Negro Affairs. Although these leaders were not officially cabinet members, their role in advising the President on black employment, education, and civil rights issues led the press to refer to them as FDR's "Black Cabinet" or the "Black Brain Trust."

This informal group of African-American public policy advisors was to help the country emerge from the depression. Omega men Robert C. Weaver, Lawrence Oxley, Roscoe Brown, Frank Horne, William Hastie, J. Arthur Weiseger, Ted Poston, Campbell C. Johnson and William Trent were among those who served on the cabinet.

**Bro. Lawrence Oxley** was appointed to the US Department of Labor. In addition to working on programs in their respective areas in executive agencies, the appointees served as unofficial advisers to the president on New Deal programs, and their impact on African-American communities during the Great Depression cannot be overstated. Oxley worked on programs to improve employment opportunities for African Americans. In 1937, he published "Government Employment and Negro Youth", an article encouraging use of the U.S. Employment Services opportunities. By publishing in a widely read journal, Oxley used an existing network to distribute information about government programs.

**Bro. Robert Clifton Weaver** in 1933, Weaver was appointed as an aide to United States Secretary of the Interior Harold L. Ickes. Coming with a reputation for knowledge about housing issues, Bro. Weaver was invited to join President Franklin D. Roosevelt's Black Cabinet in 1934.

Bro. Weaver had expressed his concerns about African American housing issues in his 1930 article, "Negroes Need Housing," published by the NAACP magazine *The Crisis* after the Stock Market Crash. He noted there was a great difference between the income of most African Americans and the cost of living; African Americans did not have enough housing supply because of many social factors, including the long economic decline of rural areas in the South. He suggested a government housing program to enable African Americans the chance to buy or rent housing.

Bro. Weaver drafted the U.S Housing Program under Roosevelt, which was established in 1937. The program was intended to provide financial support to local housing departments, as a subsidy toward lowering the

rent paid by poor African American families. The program decreased the average rent from \$19.47 per month to \$16.80 per month. Weaver claimed the scope of this program was insufficient, as there were still many African Americans who made less than the average income. They could not afford to pay for both food and housing. In addition, generally restricted to segregated housing, African Americans could not necessarily take advantage of other subsidized housing.

**Bro. William J Trent Jr.** held Government posts in Washington from 1938 to 1944, during the Administration of President Franklin D. Roosevelt, first as an official of the Department of the Interior with the title of Adviser on Negro Affairs to the Secretary of the Interior, Harold L. Ickes, and then as race relations officer in the Federal Works Agency.

**Bro. Ted Poston**, as head of the Negro News desk in the Office of War Information, Poston provided vital information to black newspapers across the nation in the campaign to integrate the defense industry workforce. His efforts were partly responsible for Executive Order 8802 in June 1941, which banned racial discrimination in companies with government contracts. After World War II, Poston wrote serialized short stories for various newspapers. Most of these stories addressed issues of social justice and racial discrimination. He wrote a series, "Horror in the Sunny South," about the 1949 rape trial of a group of young black men in Florida. The series received the George Polk Award for national reporting in 1949.

**Bro. Colonel Campbell C. Johnson** served as an advisor on race issues in the Select Service system. In 1940 he was as an assistant to the Director of Select Services. He was Director of the Racial Relations section of the Select Services, and an assistant to the Director. The Marine Corps first opened themselves to Black volunteers in 1942. To the dismay of the Marines, only 63 African Americans joined. Lieutenant Colonel Campbell C. Johnson decided that he would actively recruit Black Marines. Due to his efforts African Americans began joining the Marine Corps in droves, at a rate of more than 1,000 a month in 1943.

**Bro. Dr. Frank S. Horne** accepted a call from Mary McLeod Bethune, in 1936, to work in Franklin Delano Roosevelt's "Black Cabinet" as Assistant Director of the Division of Negro Affairs' National Youth Administration in Washington D.C. In 1938, he joined Robert C. Weaver as Assistant Director for the United States Housing Authority, later named the Federal Public Housing Administration (FHA). In addition, he was involved with the National Housing Agency and Office of Housing Expeditor. In 1949, he was designated a member of the Civil Service Committee of Expert Examiners for the Housing and Home Finance Agency (HHFA). In May of 1950, he conducted HHFA research into the economic situation of Negro war workers. Horne was noted as being one of the founders of the National Committee Against Discrimination in Housing (NCDH). In October of 1953, Horne was reassigned as "Assistant to the Administrator" of the HHFA after the Eisenhower administration made a concentrated effort to dismiss him.

**Bro. Dr. Roscoe Brown** was a pioneer in the field of Public Health, particularly as it pertained to African-Americans. Dr. Brown, a successful Dentist, gave up his practice to serve in the U.S. Public Health Service. Bro. J. Arthur Weiseger was an advisor to the Department of Labor. Overall FDR's administration tripled the number of African Americans working for the federal government, including thousands of black engineers, architects, lawyers, librarians, office managers, and other professionals. Under President Roosevelt's leadership, and with the strong support of his wife Eleanor Roosevelt, the Democrats included the first specific African American plank in the party platform at their 1936 convention.

# Historical Perspective from Dec. '49 Oracle

## IS HASTIE HEADED FOR SUPREME COURT BENCH?

**W**ILLIAM HENRY Hastie might very well be the first American of African descent to achieve a seat on the bench of the United States Supreme Court.

He has just been appointed by President Harry S. Truman to the highest judicial post ever filled by a Negro, the United States Circuit Court of Appeals. Only court higher is the Supreme Court.

*Exclusion of traditional presidential appointments of Negroes to the District of Columbia Municipal Court. Judge-designate HASTIE was the first of his race to preside in a federal court.*

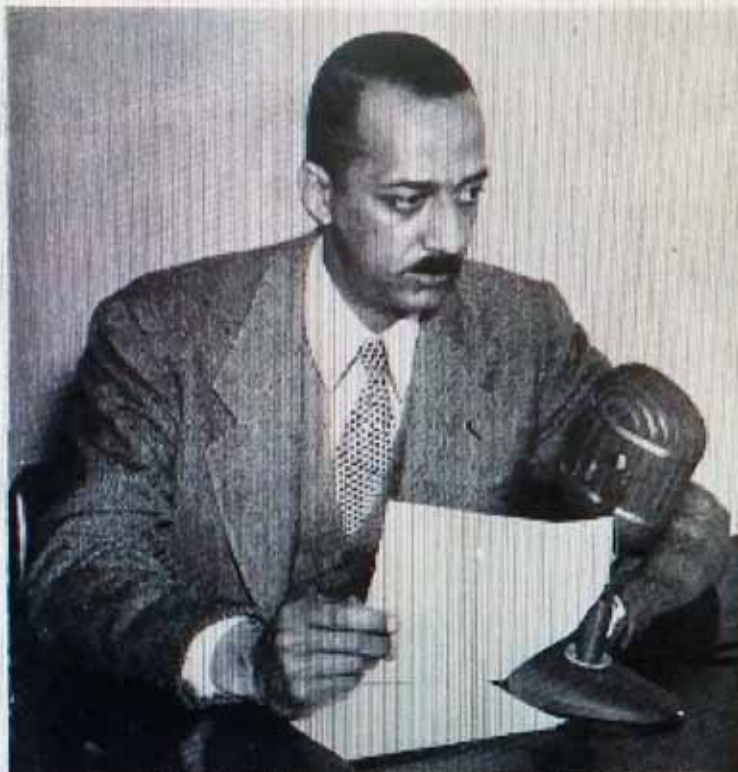
On Feb. 5, 1947, President Roosevelt nominated him as judge of the U. S. District Court for the Virgin Islands. He has been governor of the islands since May, 1946, also by Rooseveltian appointment. All governors of the Virgin Islands before him had been white.

Judge Hastie has indeed had a remarkable career. As President Truman said at St. Thomas Island during his February, 1948, Caribbean tour, while an Interior Department solicitor, he drafted the law, later passed by Congress, under which the islands are administered; he then interpreted the law as district federal judge; and finally administered the islands as governor.

Following a brilliant college career at Amherst and Harvard, Judge Hastie has served notably as a government attorney, a judge, a governor, a law professor and dean of law at Howard University, and as the first civilian aide to Secretary of War Henry L. Stimson.

He resigned from the latter post in protest against Army Air Forces racial policies. The dignity and compelling logic of his resignation focused attention on the problem and paved the way for the progressive developments which have come in the Air Force and the Navy particularly.

*Oddly enough, although his strictures on military policy were sharp criticism of conditions intended by Mr. Roosevelt, but not up to them*

*materially improved by him. Judge HASTIE has not suffered the penalties often borne by men whose action is similar.*

Not the least of his accomplishments was his handling of numerous legal suits testing civil rights, voting denials, and educational inequalities. Some years ago he was awarded the Spingarn Medal, and eminently merited it.

An intellectual who can also match the best in the rough-and-tumble of politics, Judge Hastie's entire career strengthens the conviction that he will prove to be a widely respected and influential member of the federal appellate bench. He will bring honor to an honored profession.

In the next ten or dozen years—Judge Hastie is now only 45—there will be a Supreme Court vacancy for which he should have proved himself wholly qualified.

The President then in office—and the Senate—will have an historic opportunity to prove that ability need not be forfeited by race and that America is, in fact, the land of opportunity—and democracy.

## Governor, City Officials Join in Welcome to Hastie

ROCKY MOUNT, N. C.—The conviction that the day is approaching when the South will be the center of liberalism in America was expressed here by Governor William H. Hastie of the Virgin Islands.

Governor Hastie, who was introduced by Governor W. Kerr Scott of North Carolina, spoke in the Booker T. Washington High School Auditorium before a capacity crowd of 2,500 from Eastern North Carolina.

The chief executive of the Virgin Islands pointed to the election of Governor Scott, who had just intro-

duced him, and the great victory of President Truman at the polls last November as proof that, despite loud blasts from Dixiecrats, the forces of liberalism are on the march in Dixie.

The present era, he declared, is an opportunity for plain people, black and white to make the South a great sector of liberal thought. Among the causes for this conviction he cited the breakdown of the barriers against voting and the demise of the "white primary." Soon millions of Negroes joining with whites in the South will use their votes for the good of all the plain people of the region, he concluded.

In introducing Governor Hastie, Governor Scott broke so-called "Southern precedents." It is recalled that Governor J. Strom Thurmond of the neighbor state of South Carolina last year withdrew an invitation sent to Hastie "by mistake." Governor Scott has already been termed one of the great liberals of the day. Since his inauguration in January, he has assured his constituents that Negroes will have a fairer participation in the affairs of North Carolina.

Governor Hastie's appearance was under sponsorship of the Rocky Mt. Civic Forum, of which Brother A. H. "Tuffy" Bryant is President. On arrival at the airport, he was greeted by Mayor J. R. Bennett and City Manager Roy Williamson.

After his formal address, Brother Hastie was guest of honor at a smoker in the home of Brother Stokes, sponsored by Alpha Omicron Chapter of the Omega Psi Phi Fraternity.

Until 1972, the first two years of ROTC were mandatory for all male students and after that period, participation became voluntary. During the 1972- 1973 school year, the Army authorized the participation of women in Army ROTC and selected Morgan's program as one the first to integrate women into their ROTC Battalions. The most recent General Officer for the Bear Battalion was Brother BG R. Scott Dingle in 2015. A total of 16 General Officers have been produced by Morgan and Coppin State in the Active, Reserve and National Guard; twelve (12) General Officers being graduates of the Bear Battalion ROTC program.

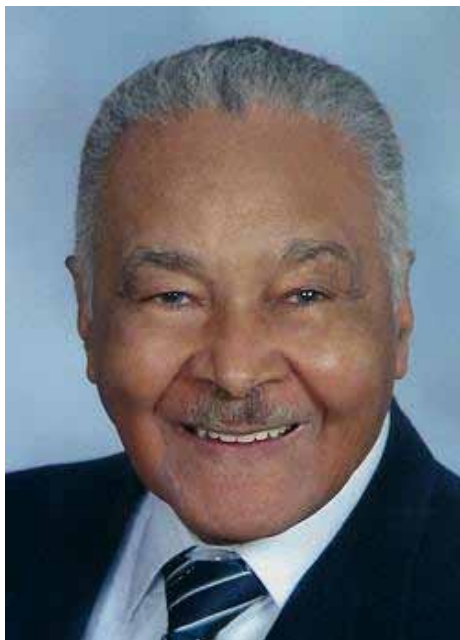

## Brother Walter Irvin Johnson, II - Omega Chapter

**Brother Walter Irvin Johnson II**, of Teaneck, NJ, born September 14th, 1915 transitioned to Omega Chapter on February 28th, 2017 at the home of his son, he was 101 years old. Brother Johnson was a member of Omega Psi Phi Fraternity for 81 years, initiated into Beta Chapter at Lincoln University in 1936. He served Beta Chapter as Vice Basileus and Basileus (1937-1939). Upon graduating, he became one of the founders of the Upsilon Alpha chapter in Atlantic City, NJ. serving as Keeper of Records and Seal until leaving for Howard. He was the last surviving founder of Upsilon Alpha Chapter. Joining Nu Beta Beta Chapter in Teaneck, NJ, he served as Historian and various committees over the years, receiving awards from both graduate chapters. Educated in Atlantic City Public Schools, graduating with honors in 1933 from Atlantic City High School, he attended Lincoln University in Pennsylvania and graduated Summa Cum Laude with a major in psy-

chology and a minor in English. Matriculating at Howard University in Washington, D.C., he earned his Master of Science degree in 1941. Subsequent advanced studies in Psychology were completed at Manhattan's New School of Social Research and at New York University. Professionally, he held positions as Professor of Psychology in Barber-Scotia College in North Carolina and Professor of Psychology and Philosophy at West Virginia State College. In 1946, however, Walter began his first stint at what would be his most satisfying employment at the Wiltwyck School for boys near Hyde Park, N.Y. He served there for eight years as senior counselor, leaving for two years to assume a position as assistant and then Director of Boys at Manhattan's Fifth Avenue Children's Center, a temporary placement center for New York's dependent and neglected children. He returned to Wiltwyck as its Resident Director in 1954, a position he held until 1959. Wiltwyck was an interracial psychiatric treatment center for 100 emotionally disturbed New York City boys between the ages of eight and 12, and was one of only seven such centers located throughout the country.

Wiltwyck's proximity to Hyde Park, the home of President Franklin Delano Roosevelt and his wife Eleanor, made it a prime object of attention for many influential people. Mrs. Roosevelt was a trustee and a most active supporter of Wiltwyck, and would visit the school almost weekly when not abroad. Other important visitors during Walter's term as director included Marian Anderson, Paul Robeson, Josh White and Harry Belafonte. Mrs. Roosevelt often invited Walter and the Wiltwyck youngsters to her estate at Hyde Park for visits during the summer as well as during the Christmas holidays.

Two young residents at that time would go on to become famous in their own right. Floyd Paterson would become the World Heavyweight Boxing Champion and Claude Brown would eventually author the acclaimed novel, "Manchild in the Promised Land." In his written autobiography, Floyd credits Walter Johnson as the person who first put boxing gloves on his hands in an attempt to get him interested in some form of gym activity. In 1961, the family moved to Teaneck and Walter accepted a position of Manhattan Assistant Administrator of New York's Youth Services Agency after holding directorships of Brooklyn's Friendly House and Manhattan's Joan of Arc Center. He continued to hold several administrative positions in the Youth Division under Mayors Lindsay, Beame and Koch before retiring from city service in 1985.

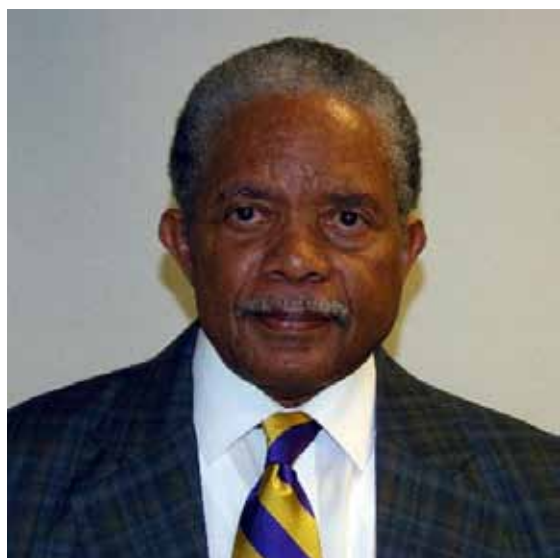
He served in the United States National Guard and was married to his college sweetheart Sylvia Ann Harris for 46 years.
